THE PRESIDENT'S REPORT

The Committee of Management has pleasure in presenting the Fifty-Sixth Annual Report and Financial Statements for the year ended 30th June, 1974.

Included in the Report are contributions from various Heads of Sections and Services of the Hospital, who report in detail the work of the Hospital.

The Hospital has progressed most favourably in the past 12 months and because of full occupancy, some enquiries for accommodation had to be refused. The Nursery has been busy with children in need of feeding adjustments and social problems, and mothers and children continue to enjoy the pleasant surroundings of the Hospital and the care and devotion of the nursing staff.

Accommodation is still provided for approximately nine little wards of State transferred from Allambie Reception Centre, and most of these little ones are healthy happy kiddies and enjoy being with us.

Since the building of a new nursery and new wing for mothers and babies was completed towards the end of 1972, the Committee of Management has concentrated on stage two of the building project, and it is planned to proceed with the building of a day care centre as soon as possible. The day care centre will accommodate 45 children up to the age of 5 years, and will be situated on the site of the old nursery facing Cardigan Street. Plans have been drawn up and approved, and the Architects, R.S. Demaine, Russell, Trundle Armstrong & Orton have estimated the cost of the building at \$105,000.00. The Centre will assist training Mothercraft nurses in the care of children as well as caring for children whose mothers have to work. A keen interest in the Hospital and the proposed new Day Nursery was shown by the Hon. A.J. Scanlan, Minister of Health, when he visited the Hospital on Friday, 10th May, 1974.

PATRONESS

Lady Delacombe, who became Patroness of the Victorian Baby Health Centres Association in 1962, regretfully relinquished her Patronage on the 31st May 1974 as she was returning to England, but I am happy to report that we have been honoured by the acceptance of Lady Winneke to be Patroness of this Association. Lady Winneke has graciously expressed her wish for a close association with the members and assistance to the cause of our Hospital.

NURSING

Due to a need for more staff, approval was obtained to appoint a further four student Mothercraft nurses and these were included in the February intake. This means that the Hospital intake of Mothercraft nurses is now

19 in each course, and this additional staff has assisted in easing the burden of the Hospital considerably. However, due to the demand of Infant Welfare trainees to be rostered 9.00 a.m. to 5.30 p.m. Monday to Friday, a further need of two fully trained Sisters and four fully trained Mothercraft nurses is required.

Mothercraft nurses are now required to spend more time at Kindergarten for further training, and as the University Day Creche could not accommodate additional nurses, the Carlton Central Kindergarten agreed to accept some trainees. Many mothers attending the Hospital during the year have received instruction in Mothercraft. It has also been reported that in England the Australian Mothercraft nurses are eagerly sought after as Nannies, and are always assured of a very sincere welcome.

NURSING APPOINTMENTS

Early in July the following appointments were made.

SISTER STOTT who had undertaken to fill the vacancy of Matron until a new appointment was made, fulfilled this position most capably, and during October 1973, informed the Committee that as a new Matron had been appointed, she wished to retire. The Committee congratulated Sister Stott on her 22 years with the Hospital and requested that she remain for a further 12 months as relieving Sister. I am pleased to report that Sister Stott was happy to accept this appointment.

MATRON OF THE HOSPITAL

Miss Lorna RICHARDSON transferred from the Queen Victoria Hospital and was appointed Matron of the Queen Elizabeth Hospital on October 8th 1973. At the Queen Victoria Hospital she was employed as a Charge Sister of a post-natal ward for 16 years, and in 1972 was awarded a Florence Nightingale Scholarship to study for the Diploma of Nursing Administration at the College of Nursing Australia. This degree was obtained during November 1973. Congratulations are extended to Miss Richardson.

NURSE EDUCATOR

Sister McCARTHY - appointed Nurse Educator on July 16th, 1974 came to this Hospital from the Royal Childrens' Hospital where she had been employed as Tutor Sister for the previous 5 years. Her general training was undertaken at the Queen Victoria Hospital and since then she has had many years of valued experience, and during 1968 was relieving Assistant Matron at the Queen Elizabeth. She was welcomed to the staff and has made valuable contributions to the plans for the teaching of trainees.

FINANCE - Maintenance

I regret to report a deficit of \$1,621.00 for the year. Maintenance expenditure totalled \$279,896.00, salaries and wages amounting to 71.2 per cent of this figure. Government Grants amounted to \$144,184.00 and patients' fees \$116,913.00. Donations and other income \$17,178.00.

CAPITAL

Donations to Capital funds amounted to \$1,539 and a Capital Grant of \$500.00 from the Hospitals and Charities Commission is appreciated very much.

COMMITTEE RESIGNATIONS

On June 19th, 1974, Mr. Scott-Young, Honorary Treasurer of the Association for the past three years, informed the Committee that he would be resigning at the end of June. Mr. Scott-Young has given highly valued service to the Hospital and was particularly interested in the establishment and building of the new wing and assisted greatly in advice on financial matters. The Committee's appreciation of this service is extended to him and it is regretted that he will not be with us when the Day Nursery project is Commenced. Our very best wishes for the future are extended to Mr. Scott-Young.

The resignation of Mrs. A. Whalley, due to very heavy commitments was received with regret. Her assistance to the Committee was valued highly and very much appreciated.

STAFF RESIGNATIONS

Sister Newbury, Lecturing Sister to schools, officially retired from the Hospital on 1st December 1973 and the Committee records their appreciation of her service.

Mrs. Yee, Secretary to the Administrator for several years resigned from the Hospital on the 21st June, 1974. Mrs. Yee was a very valued, conscientious and loyal member of staff, and her services will be greatly missed.

FAMILY PLANNING ASSOCIATION

The Family Planning Association continue to hold meetings at this Hospital on Tuesday mornings, but the usual Monday night clinic is now held at their Headquarters in Richmond.

AWARDS

The Dr. Doris Officer Scholarship, valued at \$150.00 was awarded to Sister Mather, Sister Poon and Sister Ramsay. This Scholarship is awarded to a Sister in the three training courses each year.

The Margaret White Prize given to the Infant Welfare Trainee considered the "Best in the Year" and valued at \$50.00 was awarded to Sister F. Burns.

The Sir Herbert and Lady Olney Prize, valued at \$6.30 for the Infant Welfare Trainee considered "Most suitable for Baby Health Centre Work" in each term was awarded to Sister Jeleff, Sister Burger and Sister J. Merkel.

The Committee congratulates the winners on their success.

THE HONORARY MEDICAL STAFF

It is with pleasure that the Committee acknowledges the devoted service which all Members of the Honorary Medical Staff continue to give to the Hospital. During the year, Dr. E. Turner resigned her position as President and this vacancy was accepted by Dr. Ruth Walker. Gratitude is extended to both Doctors for their dedication and acceptance of this position.

AUXILIARY ORGANIZATIONS

A warm tribute is paid to the Pied Pipers and the Birrahlee Committees for their continued support and donations to the Hospital during the year. Both Committees are keenly interested in the proposed Day Care Centre and an Adventure Playground, and are working to assist with these projects. In addition, a Kenwood Chef was presented to the Hospital by the Birrahlee Committee and an Overhead Projector and Transparency Maker and a new nursery monitor to enable babies in the isolation ward to be heard outside, were presented by the Pied Pipers. Our thanks are extended to the Caulfield Baby Health Centres Committee for their very many donations to assist with equipment for the Nursery Play Rooms, and to Mrs. Rice and her Committee who raised over \$1000 to aid the Hospital by holding a function at the Town Hall, and to Mrs. Lynch who worked so hard in assisting in the raising of \$535.00 at a function held at Realities Galleries.

ACKNOWLEDGEMENTS and the state of the state

During the year the Hospital received assistance from a large number of organisations and people. In particular, gratitude is expressed to the Government of Victoria, the Commonwealth Government and the Hospitals and Charities Commission for financial assistance. We thank the Melbourne City Council, Municipal and Shire Councils, the Wastepaper and Cardboard Committee, the many Trusts from which donations have been received and the many donors who are recorded separately in this report. At our first meeting we were very pleased to welcome Miss Lorna Richardson as the new Matron. Her fine personal qualities and high nursing standards were well known to those Of us who had worked with her before her appointment to this Hospital.

Seven business meetings were held throughout the year. At these representatives of the Committee of Management and nursing staff presented matters of mutual interest for discussion. MATRON'S REPORT

I am happy to be writing this first report since my appointment

The new hospital has been kept busy throughout the year, the parents and staff greatly appreciating the homely atmosphere and pleasant surroundings.

There has been an increase in both the number of our mothers needing extra support from our consulting psychiatrist, Dr. Linane and the number of disturbed children admitted as patients.

The nursery section has been adequately filled with children, many having feeding problems.

We have eleven State Wards in our care at present, three children belonging to one family.

Sarah, a State Ward who had been with us for four years was adopted and has settled in well with a farming family.

The Infant Welfare Sisters are well on the way to full student status now working 9.00 a.m. to 5.30 p.m., 5 days a week.

Sister McCarthy joined our staff as part-time Tutor and the students have appreciated the extra tuition given.

The Infant Welfare Centre continues to provide vital care and advice but to a gradually diminishing number of mothers.

During the past year several Mothercraft Nurses and Infant Welfare Sisters have gained distinctions in their final exams

INFANT WELFARE CENTRE

The Health Centre has been generally quite busy but attendances are slowly falling. Birth Notifications have been less following the pattern of a lower birthrate at the two maternity hospitals which service my area; The Royal Womens' Hospital and the Queen Victoria Hospital.

Home visiting has increased and the mothers seem happy to have visits from the Infant Welfare Trainees and myself.

The Family Planning Clinic has ceased its Monday night session but is kept very busy on Tuesdays when the Clinic is open from 9.00 a.m. to 12.30 p.m. It is most convenient for my mothers to have a Clinic so close.

The Monash Paediatric Professorial Unit and Dr. M. Wadds have continued to give clinics each Wednesday. The Trainee Sisters benefit greatly from these. Dr. Broderick, Pre School Officer for the Melbourne City Council has continued her monthly examination of Pre School children. The Trainee Sisters are allowed to sit in on these examinations.

The number of families with social economic problems continues to increase and I am most grateful to Sr. A. Brain, Social Welfare Officer with the Melbourne City Council for her help and advice concerning these families.

Two children who have been attending the Infant Welfare Centre have died during the last year, one at three months of a "Cot Death" and a nine month old boy of meningitis.

AIMS AND OBJECTS OF THE

ASSOCIATION

- 1. To safeguard the health of mothers and babies.
- To encourage the breast feeding of infants.
- 3. To equip and maintain a Hospital and Babies Home, and Infant Welfare and Mothercraft Training School, with Model Baby Health Centre for:
 - (a) The special training of Infant Welfare Sisters and Mothercraft Nurses.
 - b) The provision of education for mothers with a view to enabling them to bring up their children in accordance with modern health principles.
 - (c) The provision of accommodation for the education and care of mothers and babies, especially nursing mothers, and for difficult, delicate or premature babies who may require special investigation and expert care in regard to their rearing, and to provide temporary emergency care for mothers and babies or temporary care for children in time of family crisis.
- 4. To establish and operate a Day Care Centre for the care and education of children.
- 5. To arrange for organised teaching to women on the care of the
 - a) expectant mother,
 - (b) the mother, and
 - (c) children

and to disseminate such knowledge by every available means.

6. To co-operate with all present or future organisations working for the same objects.
